SECTION III – HAZARDS IDENTIFICATION

Route of Entry: Eye, skin contact, ingestion.

Potential Health Effects:

Eye Contact: May cause mild irritation.

Skin Contact: No irritation expected.

Inhalation: No hazards under normal conditions of use. No irritation expected.

Ingestion: May cause gastro-intestinal irritation with nausea, vomiting and diarrhea.

Chronic Effects/Carcinogenicity:

Carcinogenicity: No ingredients listed by IARC or NTP. Non-hazardous by WHMIS standards.

SECTION IV – FIRST AID MEASURES

Eye Contact: Flush with water for 15 minutes. Seek medical attention if irritation persists.

Skin Contact: No special measures are required.

Inhalation: Remove to fresh air and take deep, slow breaths. Seek medical attention if irritation persists.

Ingestion: Do not induce vomiting. Rinse mouth with water, then drink one glass of water. Seek medical attention if symptoms persist.

Product is readily biodegradable as per OECD Test Method 301D. For large quantities, dispose of in accordance with local, state/provincial and federal laws.

Storage Requirements: KEEP OUT OF REACH OF CHILDREN. Store in closed container. Store away from incompatible materials.

SECTION XI – TOXICOLOGICAL INFORMATION

The calculated LD₅₀ of the product is 5714 mg/kg (oral, rat). This product is not expected to be irritating to the eyes or skin upon prolonged contact.

SECTION XII – ECOLOGICAL INFORMATION

Biodegradability: All organic ingredients of this formula have been tested by an independent laboratory and all are readily biodegradable as measured by OECD Test Method 301D. This measures biodegradability under load and in simulated real life conditions.

Aquatic Acute Toxicity: 96 hour Rainbow trout LC₅₀>80 mg/L
(At concentrate) 48 hour Daphnia magna LC₅₀>80 mg/L
72 hour Algae growth inhibition test LC₅₀ 156 mg/L

These results exceed standards to 10 mg/L set by recognized testing authorities for green products.
